

4-H FAIR PRINCESS CONTEST

OFFICIAL RULES & REGULATIONS:

1. Each contestant must be at least 12 years of age and cannot have had her 16th birthday as of June 1, 2018.
2. The contestant must be a resident of Bartholomew County.
3. An informational meeting will be held at the Fair Office in June.
4. Interviews will be held prior to the Princess Contest. Individual times will be determined and a call made to confirm the interview time.
5. The contestants will be judged on the basis of beauty, poise and personality in the competition. This judging is divided into four divisions:

DIVISION I

Maximum 3 minute interviews – 40 points total: Ability to converse-15 points, Poise-10 points, and Personality-15 points. Attire: Business attire (may be skirt or pants) or dress.

DIVISION II

Professional Wear – 20 points total: Posture and poise-10 points; overall impression-10 points. Attire: Business wear (maybe dress, skirt or pants). Dresses with the skirt split above the knee (more than 2 inches above the knee cap) will be discounted and /or the judges will discount a low-cut bodice. Attire worn by contestant in interview will also be worn / judged in professional wear category. Props are not allowed.

DIVISION III

Theme wear-15 points total: a representation of you, personality, goal and/or interest (fun at the fair). Props are allowed.

DIVISION IV

Formal wear-25 points total: Stage presence-10 points; Overall impressions-15 points. Attire: The dress may be any length. Dresses with the skirt split above the knee (more than 2 inches above the kneecap) will be discounted and / or the judges will discount a low-cut bodice.

Winners will be selected by a board of judges and the decision of the board will be final. The Princess will reign during the Bartholomew County 4-H Fair July 6-14, 2018. Each contestant must be an active member of at least one worthwhile organization in her community, such as church groups, 4-H, Girl Scouts, etc. Eligibility is not limited to 4-H.
