## OFFICIAL RULES & REGULATIONS:

1. Each contestant must be at least 12 years of age and cannot have had her 16th birthday as of June 1, 2020.
2. The contestant must be a resident of Bartholomew County.
3. An informational meeting will be held at the Fair Office in June.
4. Interviews will be held prior to the Princess Contest. Individual times will be determined and given out at the parent meeting.
5. The contestants will be judged on the basis of beauty, poise and personality in the competition. This judging is divided into four divisions:



### DIVISION I

Maximum 3 minute interviews – 40 points total: Attire: Sunday best attire (may be skirt or pants) or dress.

### DIVISION II

Sunday Best – 20 points total: Attire: A dress, skirt, or pants that you would wear to church or other nice event.

### DIVISION III

Theme wear-15 points total: a representation of you, personality, goal and/or interest (fun at the fair). Props are allowed.

### DIVISION IV

Formal wear-25 points total: Attire: The dress may be any length. No slit above the knee or low-cut bodice. Dress should be age appropriate.

Winners will be selected by a board of judges and the decision of the board will be final. The Princess will reign during the Bartholomew County 4-H Fair July 10-18, 2020. Each contestant must be an active member of at least one worthwhile organization in her community, such as church groups, 4-H, Girl Scouts, etc. Eligibility is not limited to 4-H.
